The sacred culture which makes our head raise high over the world and the message of non-violence may decline and the soul of great people like Mahatma Gandhi will not find peace.

## Forms of euthanasia:

There are many forms of euthanasia.

- e.g. 1. Before the child is born, it is killed in the mother's womb. In many places, girl child is killed just after giving birth to them.
- 2. Sometimes, even doctors have been seen giving medicines to sick to put them to eternal sleep.
- 3. In the modern era, there has been a decline in good attitude and service towards patients and old people which has resulted in increased deaths due to lack of care and medications at the right time.
- 4. It has also been noted that the sick wanting to embrace death as they find themselves in dire helplessness. The suffering makes people wanting to separate themselves from this world while the curing process makes them think otherwise.
- 5. Sick people are put to death without their permission. Whatever be the case, this type of death is murder. We see people who show euthanasia in their expressions and thoughts in public. When a sick person becomes a burden, he is killed by others and is called by the name beloved. A person is a human being even if he cannot contribute anything to the society. No one has the right to take his life. Those who support it resort to the law to suppress violence. Then there is the use of legally recognized violence. The lack of human sensibilities can be seen in the personality of such people. The motive behind euthanasia is always pure selfishness or personal profits. It is never non-violent. It is the enemy of human

rights. In a country where it is recognized as a statutory, abuse of human rights is bound to happen on a large scale. The victims of this abuse are mostly people who are helpless. Therefore, it would not be unreasonable to call it the enemy of human rights.

The path of violence is easy, but it is destructive. Violence done by man is not only an indicator of animal instinct, but also an indicator of being devoid of thinking ability, intelligence, conscience and possessing a narrow and cruel mentality. A person who possesses a narrow mind adopts the path of violence. Violence if done purposely indicates degradation from the human condition. Wisdom is the entity that separates man from the animal. Wisdom is the proof of human being's humanity.

Therefore euthanasia is an indicator of the decline of humanity that is visible in the decline of forgiveness, kindness, affection, and benevolence that have resulted in paving the way for euthanasia. #### **Consequences:**

Euthanasia is a heinous crime against humanity and God and hence unethical<sup>3</sup>. The root cause of its condemnation lies in its inhumanity. It's anti-life. No one has the right to implement it from any point of view. because it is against Indian culture and humanity. Death doesn't give happiness to anyone. It is a cause of sorrow in front of our eyes. How would we feel if a loved one is killed in front of our eyes? Everyone has the right to live. But we should understand that if the governance system advocates euthanasia, if the helpless people in the society continue to bear it and if those who support it give recognition for this selfish interest, then the victory is not for human rights and non-violence, but for violence, *i.e.*, victory is of Hitlerism -and not of Gandhism.
